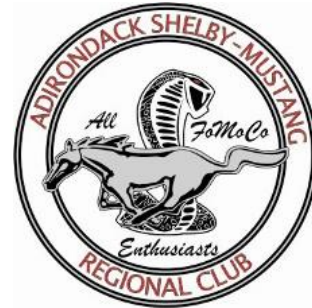

Please pay your dues in January if possible, so we can put this task to rest and move on to other things. Make a check out to A.S.M.C. and send it to:

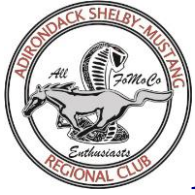




